## Perrin Love



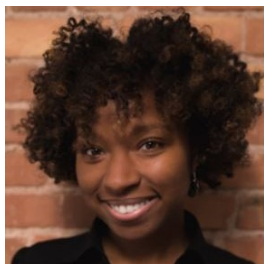
### *Slated to serve first term as Board Member-at-Large*
