WHEN THE POLICY MANUAL IS REVISED EVERY TWO YEARS, EACH STAFF MEMBER RECEIVES A FRESH COPY AND IS ASKED TO RE-SIGN THE CONFLICT OF INTEREST POLICY STATEMENT. IF A SITUATION OR OCCURRENCE ARISES IN WHICH A STAFF MEMBERS CONFLICT OF INTEREST IS QUESTIONED, A FULL INVESTIGATION AND REVIEW IS CONDUCTED TO INCLUDE A FACT-FINDING STAGE, INTERVIEW(S), EVALUATION, AND CONCLUSION. IF THERE IS A CONFLICT OF INTEREST IN WHICH A STAFF MEMBER MAY BE SEEN AS COMPETING WITH THE INTEREST AND CONCERNS OF GSU, ANY MATTERS THAT ARISE WILL BE REFERRED TO THE CEO FOR NECESSARY ACTION. DISCIPLINARY ACTION, UP TO AND INCLUDING SEPARATION OF EMPLOYMENT, MAY OCCUR.

EACH BOARD MEMBER FILES A CONFLICT OF INTEREST STATEMENT EVERY YEAR AND ARE PROVIDED WITH THE FORM AT EVERY BOARD MEETING FOR CHANGES.
