



**2025 COOKIE PRODUCT PROGRAM**  
**Caregiver Permission & Responsibility Agreement**

My Girl Scout \_\_\_\_\_, a registered member of Troop \_\_\_\_\_, has my permission to participate in the 2025 Girl Scout Cookie Product Program. I will see that they honor any and all rules and procedures as set by Girl Scouts of Utah (GSU). I will see that they have adult supervision and guidance at all times, and I will adhere to the published starting dates for order taking. I will follow the GSU Product Program Policies and Standards:

- 1) My Girl Scout must be a currently registered Girl Scout for the 2024-2025 membership year.
- 2) I accept personal financial responsibility for all product received and monies collected as payment from customers.
- 3) I understand that the 2025 Cookie Product Program proceeds are troop & council property and that the income from product sales does not become the property of individual Girl Scout members.
- 4) I will ensure the Troop Product Manager provides signed receipts for all product & rewards received and monies turned in so I have an accurate financial accounting of the monies owed to GSU.
- 5) I agree that all money collected must be given to my Girl Scout's troop on or before April 2, 2025, or any earned reward items, including activity credits, will be withheld until GSU receives the outstanding balance.
- 6) If my account is delinquent and not brought current prior to the expiration of ticketed or time-sensitive recognition items, GSU will not be obligated to reissue, replace, substitute, or refund the value of said recognitions.
- 7) GSU reserves the right to seek the services of a collection agency and/or pursue legal action for delinquent accounts. I agree to pay all costs of collection including an additional fee of 35%. I further agree to pay all court costs and attorney's fees should legal action become necessary.
- 8) Any Girl Scout found to be selling before the official start dates, or through prohibited methods, may not receive reward items or activity credits.
- 9) I understand unsold product cannot be returned to my troop or to GSU.
- 10) I understand I am financially responsible if any product, money, or rewards are lost, stolen, or damaged while in my possession.
- 11) For safety purposes and other reasons, Girl Scout online sales links may only be shared via social media posts with friends and family and only when the user's profile is set to private. Girl Scout contact information, online sales links, or sales information may not be shared or marketed on public-facing online sites (Facebook, Instagram, and Neighborhood), any site that is "closed" but includes the public, nor with any news outlets.
