Treasurer's Report: Steve Smith

Steve presented a report on finances for the council in FY2022. He reported 2021 and 2022 Revenue vs. Last Year and noted that our we had a \$850k loss in our investments so that accounted for the revenue difference shown between 2021 and 2022.

Steve also presented Expenses vs Last Year with our Girl Program, general expenses and fundraising expenses. He explained that the reason our expenses went up in 2022 vs. 2021 was the fact that we were able to open more programming in 2022.

Steve concluded his report by reviewing the Cloud Rim loan balance that was officially paid off in full as of 9/30/22.

Governance Report: Leslie Egan

Leslie recognized and thanked our National Delegates for their work and preparation for Town Hall, Annual Meeting, and the upcoming National Council Session. Tanya Yu was announced as one of 13 girls chosen as a Presiding Officer for the 56th National Council Session.

The work of the outgoing 2019-2022 National Delegates was recognized as they served during a unique time during the global health pandemic.

The 2021-2022 Youth Board Representatives were recognized for their participation in Board Meetings during their year tenure.

Dates for Camping for a Cause (August 18-19 2023) and Utah Day of the Girl (October 6, 2023) were announced. Leslie gave a recap of both events from 2022.

Leslie read a letter from the Board of Directors to the meeting attendees addressing the Camp Cloud Rim 25 cent decision. This letter was sent out to all members of GSU on 5/1/23.



Operations Report: Lisa Hardin-Reynolds

I want to share with you our report of the 2021-2022 membership year.

It's my great honor to share with you the highlights and I would like to share with you some of the amazing things that we have accomplished together. The 22-membership year was another year of providing Girl scouting for the Covid pandemic.

I am extremely proud of how resourceful our dedicated volunteers, staff and members have been throughout this year. As you know the pandemic changed the way. We do everything, and we continue to put what we learned to great use. As we navigated the membership year, we were able to move closer to a more normal way of work and get back to serving girls directly in our troops and through our council programs and camps which were back in full operation. Let me begin my report to you first by saying that the Girl Scouts of Utah is in a strong and stable place due to the remarkable perseverance, talents, and dedication of our amazing volunteers, Board and Staff. Councils across the country continue to struggle with the challenges of Covid recovery with Cookie challenges, and with the decreasing membership that the pandemic brought. We certainly have been challenged as well. But as you will hear from my report, we have done remarkably well and the reason for that difference is you.

I would like to begin with our membership. Our girls are the heart of everything. We do. As we look over the past membership here several accomplishments, rise to the top in 22, we anticipated and prepared for Covid membership challenges. Thanks to you and all of your support we ended our membership here on September 30, 2022, with 5,471 girls. Increasing our girl membership by nearly 5% over 2021. More good news, Girl Scouts of Utah completed our membership here with an impressive girl retention rate of 69.7%, which is higher than the national average, which is an amazing 6% increase over last year.

Our Girl Scout Outreach Program serves girls, and after school programs, refugee centers and at homeless and domestic violence shelters, and community partner locations. Here we serve 553 girls through our Outreach Program.

This year our youngest members are Daisies and Brownies make up 47% of our girl membership. Our Juniors and Cadettes are 44% of our membership. That means that our Seniors and Ambassadors account for exactly what they did in the previous year, remaining steady at 9%

We know that our teen girls get so much from Girl Scouting, and I would challenge all of us to think about ways we can encourage those younger girls to stick with girl scouting, so they, too, can experience all the travel, opportunities, and adventures that our seniors and ambassadors enjoy. Recruiting Girl New girl members continues to be a focus for us, and I



know you believe, as I do, that every girl needs and deserves the opportunity to be a Girl Scout.

The strength of our movement rests in our volunteers. So now I want to turn to our adult volunteer membership. We continue to focus on recruiting new volunteers to start new troops throughout our Council. Our volunteer support team focused on volunteer engagement and Service shouldn't it help. Once again, we gathered at Trefoil Ranch for our annual leadership summit, providing training and guidance for service units, success, and all the service units due to support the troops in their areas. For the 22-membership year. Our council's total membership reached 3,023 adults. This is so amazing because it's an 18% over 2021. Clearly, we have incredible volunteers who are deeply dedicated to serving all girls, and who are immensely grateful for your efforts to ensure that ours is a council that truly exemplifies the sisterhood of caring and inclusion.

As we looked more closely at our efforts for inclusion. We intentionally reviewed all our work through a lens of diversity. We are constantly focused on how and where we can improve inclusivity in our services for girls and adults. We continue to evaluate and focus on excellent recruitment and retention efforts as we work on our girl and adult membership. With your help our current girl membership here will reflect an even greater girl and adult membership recovery from the challenges we have faced the last few years.

Now let's turn our attention to our program efforts. Service units across our Council provide even more program experiences to girls offering cookie Rallies, world thinking day events, and day camps. As you know, Girl Scouting programming is based on the 4 program pillars. Life Skills, STEM, Entrepreneurship and the Outdoors creating a well-rounded experience for girls. During our membership year. In addition to troop and service unit organized activities, our council serves more than 4,000 girls with experiences centered on one of the 4 pillars.

Our most popular pillar remains the outdoor pillar and 2,906 girls participated in outdoor camping programs. Resident camp attendance alone increased by 15% in campers and joined horseback riding, hiking, rock climbing, archery, kayaking, and of course exploring our ropes course. Once again GSU met the rigorous requirements to earn an American Camp Association Accreditation for Camp Cloud Rim and Trefoil Ranch.

Life skills, programs, help girls build strong positive values and gain the skills needed to overcome obstacles. During the membership year, we held a day long camp fury event for cadets, seniors, and ambassadors who learned about public safety careers with the help of local firefighters, police officers, and EMTs. Another highlight was 4 girls from GSU were selected to join the GSUSA delegation at the 66 commission on the status of women hosted by the United Nations. During this weeklong event they added their voices to those of other



young women and teenagers from around the world, learning how to create an advanced public policy aimed at the empowerment of women and girls in climate change, environmental and disaster. disaster, risk reduction programs.

Through STEM. Our science, technology, engineering, and math programs. Girls advance their problem solving and critical thinking skills. entrepreneurship programs, provide opportunities for girls to develop strong people, skills and build a valuable work ethic.

To prep for the 22 Cookie Program Girl Scouts were invited to 3 virtual training events with our cookie Bakers girls also participated in fun. Cookie Rallies held on their service students. The Cookie program, as you know, is a big part of how we can afford to provide Utah girls with Girl Scouting as a council. We are a huge thank you to every girl, volunteer, parent, and staff member that has helped our Council navigate our incredibly challenging cookie seasons.

So now for the big news by embracing the digital sales platform and employing a number of innovative sales, tactics such as cookies on the go, 2,862 girls so over they sold 1,233,053 boxes of cookies. In addition, we donated 25,545 packages to the Utah Food Bank.

I know that all of you share with me the pride we feel when a girl goes for, and she's one of Girl Scouting's highest. Awards Girl Scouting has a long legacy of challenging girls to use their skills to make the world a better place. The Girl Scout Bronze award, Silver award, and the Gold award prove that girls who strive to earn them have the leadership skills, project skills, and vision needed to build better today and tomorrow.

I'm pleased to share with you that we had 116 girls who earned the highest awards. This year 67 girls earned their bronze, 42 girls earned their silver, and 7 girls earned the prestigious gold award. In addition, we celebrated the incredible service of 30 of our most dedicated volunteers, receiving adult awards in 2022 this included congratulating Barbara Schmidt on earning the prestigious Freddie Award.

Now let's move on to our financial picture. The Girl Scouts of Utah will move into the next membership year on a strong stable financial footing. We have been able to keep the Council financially healthy through these uncertain times, and even allocated additional resources to strengthen our future. Steve mentioned earlier that the board of directors voted to allocate \$1.5 million dollars to make an additional principal payment on the Cloud Rim loan. That was in 2021 and I'm excited to share that that loan was paid off in 2022. A milestone accomplished through the prudent management of the council's resources, as well as the incredible support from our girls and their cookie customers, as we allocated the 25 cents per



box. Camp Cloud Rim is now truly ours and will continue to operate securely for future generations of girls.

I want to close my presentation today by thanking you, each of you for your endless patience, your dedication, your gifts of time and resources. and especially for your sincere support through this time. Honestly, we could not have gotten through these last years without you, and your support means more than I have the words to tell you. I also want to thank the GSU Staff, you have over and over demonstrated your resilience, your innovation, your dedication, and your passion for Girl Scouting, and this organization I'm. Honored to work with each of you. Thank you for everything that you do. 2023 holds continuing challenges, and it also holds great promise, and we are eagerly looking forward.

Girls today are feeling a great deal of mental angst, and uncertainty because of disruption in the last 3 years. All of us who make up the Girl Scouts of Utah have a crucial role to play in giving Utah girls the care, the connections, and the programs to help them recover from all that the pandemic has brought into their lives. As we look back and celebrate 22, we know we are well on our way. I look forward to our next annual meeting. When I get to share with you how far we have come together.

Our council is strong and resilient, and why we do not know what challenges we may face tomorrow. We know it is Girl Scouts. We will overcome them, and we will overcome them as Girl Scouts together.

National Council Proposals Introduction and Discussion: National Delegates


